### This Year's **Gingerbread Structure**

Due to the Covid Virus the recommend restrictions on congregating and travel we decided to do our annual Gingerbread Structure earlier than usual. The choice of structure was primarily settled by the Iconic Building of the Month in our November issue. It can be found on our website for reference. As a reminder the building was Fallingwater.

Fallingwater is a house designed by architect Frank Lloyd Wright in 1935 in rural southwestern Pennsylvania, 61 miles southeast of Pittsburgh. The house was built partly over a waterfall on Bear Run in the Mill-Run section of Stewart Township, Fayette County, Pennsylvania.

After deciding on what would be the gingerbread structure of the year we need to create drawings in scale so the final product will look right.

The next step we found to be very helpful is to create a model out of paper or foam core board. We pin it together so we can take it apart and use it as a pattern (the patterns only act as approximate shapes and sizes as the gingerbread expands as it bakes) for all of the pieces of gingerbread we need to make.

Then we start rolling out the gingerbread. We cut the gingerbread to the approximate shapes and sizes and put it in the oven. As each batch cools, they are trimmed into the proper sizes and shapes.

The next step is to start building. On the inside the structure requires pieces to hold up the gingerbread above. This way the entire gingerbread structure does not have to be solid.


